

ORDINANCE NO. 25-326

ORDINANCE LEVYING AND ASSESSING PROPERTY TAX FOR
FONDULAC PUBLIC LIBRARY DISTRICT OF THE COUNTY OF TAZEWELL,
STATE OF ILLINOIS FOR THE FISCAL YEAR BEGINNING
THE 1ST DAY OF JULY 2025 AND ENDING
THE 30TH DAY OF JUNE 2026

WHEREAS, the President and Board of Trustees of the Fondulac Public Library District, in the County of Tazewell and State of Illinois, did on the 25th day of August 2025 pass the Annual Budget and Appropriation Ordinance (Ordinance no. 25-325) for said Library District for the fiscal year commencing on July 1, 2025 and ending June 30, 2026; and

WHEREAS, said Annual Budget and Appropriation Ordinance was duly published as provided by law after its passage;

NOW, THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE FONDULAC PUBLIC LIBRARY DISTRICT, IN THE COUNTY OF TAZEWELL, AND STATE OF ILLINOIS, as follows:

Section 1: That the total sum of ONE MILLION NINE HUNDRED SIXTY-FOUR THOUSAND TWO HUNDRED FIFTY-FIVE DOLLARS (\$1,964,255.00), as follows: The sum of ONE MILLION SEVEN HUNDRED FIFTY-ONE THOUSAND NINE HUNDRED NINETY DOLLARS (\$1,751,990.00), being the amount deemed required for the necessary corporate purposes of Fondulac Public Library District, Tazewell County, Illinois; the sum of EIGHTY-TWO THOUSAND EIGHT HUNDRED SEVENTY-FIVE DOLLARS (\$82,875.00), being required for the payment of employer contributions of Fondulac Public Library District to the Illinois Municipal Retirement Fund; the sum of FOURTEEN THOUSAND ONE HUNDRED EIGHTY DOLLARS (\$14,180.00), being required for the payment of the professional opinion of an accountant and other auditing expenses from an Audit Fund; the sum of TWENTY-NINE THOUSAND THREE HUNDRED FORTY-FIVE DOLLARS (\$29,345.00), for the

purpose of payments of premiums due for the purchase of liability insurance, worker's compensation, and unemployment insurance, property damage (fire) insurance and legal fees for defending or otherwise protecting itself against liability from a Liability Fund; the sum of EIGHTY-FIVE THOUSAND EIGHT HUNDRED SIXTY-FIVE DOLLARS (\$85,865.00), being required for the maintenance, repairs, and alterations of library buildings and equipment from a Maintenance Fund; be and the same is hereby levied and assessed upon and against all taxable property within this Library District according to the full fair value as established and ascertained for State and County purposes for the fiscal year beginning July 1, 2025 and ending June 30, 2026 and the Board of Trustees of the Fondulac Public Library District having on the 25th day of August, 2025 duly passed and adopted the Annual Budget and Appropriation Ordinance for the fiscal year beginning July 1, 2025 and ending June 30, 2026 and said Ordinance having been duly published in a newspaper of general circulation within the Public Library District, this Board finds that the specific purposes and the specific amounts provided for in said Annual Budget and Appropriation Ordinance, a copy of which is attached hereto and by this reference made a part hereof, are required to be levied for the necessary purposes of the Fondulac Public Library District.

Section 2: The Secretary of the Board of Trustees of the Fondulac Public Library District is hereby directed to file a duly certified copy of this Ordinance with the County Clerk of Tazewell County, Illinois, in accordance with the laws of the State of Illinois, on or before the last Tuesday of December 2025 and said County Clerk is hereby authorized and directed to extend the said tax so levied by this Ordinance, according to law, against all taxable property within the Fondulac Public Library District. The Secretary of Fondulac Public Library District shall also file on or before the last Tuesday of December 2025, duly certified copies of the Annual Budget and Appropriation Ordinance and this Ordinance with the Fondulac Public Library where they shall be available for public inspection as provided by law.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

Section 4: This Ordinance was adopted pursuant to, and in all respects in compliance with the provisions Sections 18-60 through 18-85 of the “Truth in Taxation” law. The taxing district’s aggregate levy did not exceed a 5% increase over the prior year’s extension. Therefore, notice and a hearing were not necessary.
